AGENDA TITLE: Authorize City Manager to Execute Transit/Link Transfer Agreement Between County of Sacramento and City of Lodi

MEETING DATE: September 3, 1997

RECOMMENDED ACTION: That the City Council adopt the attached resolution authorizing the City Manager to execute the Transit/Link Transfer Agreement between the County of Sacramento and the City of Lodi.

BACKGROUND INFORMATION: On September 22, 1997, the County of Sacramento will begin fixed-route all-day service, Monday through Friday, between Galt, the unincorporated Sacramento County, and the City of Lodi. The "Link" service will provide transfers to and from GrapeLine and SMART.

The transfer agreement between GrapeLine and Link would allow Link passengers to transfer to GrapeLine at no additional cost. GrapeLine passengers would pay the difference between their GrapeLine fare and Link's fare.

Each month the County and Lodi will report to each other the number of passengers that transferred between each system. The County of Sacramento or Lodi may terminate the transfer agreement with a sixty (60) day notice.


