
AGENDA TITLE: Contract Award for Mistletoe Removal and Associated Tree Trimming (approx. \$18,000)

Assuming there are no problems with the bids, an award recommendation will be presented at the Council meeting.



RECOMMENDED ACTION: That the City Council adopt the attached resolution awarding the contract for the above project to Grover Landscaping, Inc., of Modesto, in the amount of \$9,420.


BACKGROUND INFORMATION: This project will provide for mistletoe removal and associated tree trimming of 194 trees at various locations throughout the City. The objective of this contract is to retard the spread of broadleaf mistletoe by removing it from affected trees and improve the health of these trees through corrective pruning.

Berndt Tree Service was the low bidder at \$9,120. Staff determined their bid to be non-responsive due to the submittal of a personal check in lieu of stipulated "cash", "certified check", "cashier's check", or "bidders bond" as required by the City. Therefore, staff requests this contract be awarded to the second lowest bidder, Grover Landscape, Inc., in the amount of \$9,240.

Specifications for this project were approved on December 18, 1996. The City received the following three bids for this project:
