AGENDA TITLE: Renewal of Landscape Maintenance Contract for Fiscal Year 1996/97 (\$46,640)

RECOMMENDED ACTION: That the City Council adopt the attached resolution approving renewal of the existing landscape maintenance contract for the 1996/97 fiscal year to Ireland Landscape Company, Inc., of Stockton, California.

BACKGROUND INFORMATION: City Council originally approved the specifications for landscape maintenance on May 18, 1994. Section 1.5, General Stipulations, of the approved specifications allows for option to renew by mutual agreement between City and Contractor. Council first awarded the contract to Ireland Landscape Company, Inc. on June 8, 1994. During the 1994/95 and 1995/96 fiscal years, Ireland Landscape Company, Inc. has maintained forty-five landscaped areas for the City, providing satisfactory service. Two additional areas will be added for the 1996/97 fiscal year at a \$960 increase. The City elects to exercise its option for a second renewal. In the attached letter, Ireland Landscape Company, Inc. agrees to maintain the original areas at the same rate for an additional twelve months, July 1996 through June 30, 1997. It is our intent to go out to bid for landscape maintenance for the 1997/98 fiscal year.


Various departments included funds to finance the contract in the proposed 1996/97 operating budget.

CONTRACT FOR FISCAL YEAR 1996-97
