ORDINANCE NO. 1641

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LODI  
AMENDING CHAPTER 13.20 OF THE LODI MUNICIPAL CODE BY  
REPEALING AND REENACTING SECTIONS 13.20.240 AND  
13.20.250, RELATING TO ELECTRIC SERVICE - RATES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LODI AS FOLLOWS:

SECTION 1. Chapter 13.20 - Electrical Service - is hereby amended by repealing and reenacting Section 13.20.240, relating to Group 1 commercial/industrial rates by attaching new Exhibit F:

Section 13.20.240 - Schedule G1 - General Service - Group 1 Commercial/Industrial.:

For Group 1 commercial/industrial rates, see the schedule attached to the ordinance codified in this chapter, marked Exhibit F and made a part hereof as if set out in full.

SECTION 2. Chapter 13.20 - Electrical Service - is hereby amended by repealing and reenacting Section 13.20.250, relating to Group 2 Commercial/Industrial rates by attaching new Exhibit G.

Section 13.20.250 - Schedule G2 - General Service - Group 2 Commercial/Industrial.:

For Group 2 commercial/industrial rates, see the schedule attached to the ordinance codified in this chapter, marked Exhibit G and made a part hereof as if set out in full.


SECTION 3 - No Mandatory Duty of Care. This ordinance is not intended to and shall not be construed or given effect in a manner which imposes upon the City, or any officer or employee thereof, a mandatory duty of care towards persons or property within the City or outside of the City so as to provide a basis of civil liability for damages, except as otherwise imposed by law.

SECTION 4 - Severability. If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application. To this end, the provisions of this ordinance are severable. The City Council hereby declares that it would have adopted this ordinance irrespective of the invalidity of any particular portion thereof.

SECTION 5. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 6. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.
