RECOMMENDED ACTION: That the City Council adopt the attached resolution approving a program supplement to Administering Agency-State Agreement No. 10-5154 and authorizing the Public Works Director to sign the supplement.

BACKGROUND INFORMATION: This program supplement funds the Beckman Road project using Federal and State money. The project is out to bid with bids scheduled to be opened on July 26, 2000. The project consists of reconstructing approximately 160,000 square feet of asphalt concrete pavement; installing 5,900 square feet of curb, gutter, and sidewalk; miscellaneous drainage facilities; traffic striping, including bike lanes; and other incidental work.

The money allocated under the program supplement will cover the cost of construction and construction engineering. The City has paid the cost of the design engineering.

FUNDING: Funds for this project will be appropriated with contract award.


BE IT FURTHER RESOLVED, that the Public Works Director is hereby authorized and directed to execute this Agreement on behalf of the City of Lodi.
