**AGENDA TITLE:** Adopt a Resolution Awarding the Contract for 2001 Sidewalk Repair Program and Miscellaneous Concrete Work to Popuch Concrete Contracting (\$183,580); and Appropriate \$200,000 for the Project

**MEETING DATE:** February 7, 2001

**RECOMMENDED ACTION:** That the City Council adopt a resolution awarding the contract for the above project to Popuch Concrete Contracting, of Lodi, and appropriate funds in accordance with the recommendation shown below.

**BACKGROUND INFORMATION:** This bid provides the City with a unit-price for removing and replacing curb, gutter, and sidewalk in various locations throughout the city. This is an annual contract and will be used to implement the sidewalk repair program and to repair curb and gutter as needed during 2001. Purchase orders will be issued for the work to be done, thus the total of the bid is not pertinent and is only used to compare bids. A clause in the specifications will allow the City to extend the contract an additional year if it is mutually agreed upon by City staff and the contractor.

Plans and specifications for this project were approved on December 20, 2000. The City received the following four bids for this project:


BE IT FURTHER RESOLVED that funds in the amount of \$200,000.00 be appropriated from the Transportation Development Act (TDA) funds for this project.
