**AGENDA TITLE:** "No Parking" on Turner Road West of Sacramento Street

**MEETING DATE:** February 15, 1995

**PREPARED BY:** Public Works Director

**RECOMMENDED ACTION:** That the City Council adopt a resolution approving the installation of "no-parking" zones on Turner Road west of Sacramento Street (adjacent to River Pointe) as shown on Exhibit A.


**BACKGROUND INFORMATION:** Recently, Public Works Department staff reviewed the development plans for River Pointe subdivision located on the north side of Turner Road at Sacramento Street. In reviewing the plans, preliminary lane geometrics/cross sections were prepared as shown on Exhibit B. Both cross sections include bicycle lanes as recommended by the recently adopted Bicycle Master Plan.

The Bicycle Master Plan recommends Class II bicycle lanes on Turner Road where they can be accommodated. Bicycle lanes can be installed within the existing street width if "no-parking" zones are installed. Staff feels the on-street parking is not needed since the residential subdivision on the north side of Turner Road has reverse frontage parcels and the shopping center on the south side has an adequate parking lot. Currently, "no-parking" zones exist in front of River Pointe and extend east to Highway 99

Exhibits A and B show two alternatives, with and without a left-turn lane. Both alternatives require the "no-parking" zones recommended. Staff's intention is to install a left-turn lane since the forty-four residential-unit subdivision will have only one access. The posted speed limit on Turner Road near River Pointe is 40 mph with existing volumes approximately 12,000 vehicles per day. A left-turn lane will improve traffic flow, especially given the higher speeds.

Staff recommends City Council approve the "no-parking" zones as shown on Exhibit A. With the approval of "no-parking" zones, bicycle lanes can be installed from Church Street to Highway 99 as funding becomes available for the segment.

**FUNDING:** Street Maintenance Account with the approximate cost of \$350.



Proposed "No Parking" Zones




-  Existing No Parking Zone







Proposed "No Parking" Zones






With Left turn Lane


