
**RECOMMENDED ACTION:** Following reading by title, it would be appropriate for the City Council to adopt Ordinance No. 1610.

ORDINANCE NO. 1610

AN ORDINANCE OF THE LODI CITY COUNCIL  
AMENDING THE OFFICIAL DISTRICT MAP OF THE CITY OF LODI  
AND THEREBY PREZONING THE PARCEL AT THE EASTERN  
TERMINUS OF EAST TURNER ROAD (APN 049-080-73)  
M-2, HEAVY INDUSTRIAL

BE IT ORDAINED BY THE LODI CITY COUNCIL AS FOLLOWS:

SECTION 1. The Official District Map of the City of Lodi adopted by Title 17 of the Lodi Municipal Code is hereby amended as follows:


The 10.01 acre parcel located at the Eastern Terminus of East Turner Road (APN 049-080-73) is hereby prezoned M-2, Heavy Industrial, as shown on the vicinity map on file in the office of the City Clerk.

SECTION 2. The alternations, changes, and amendments of said Official District Map of the City of Lodi herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearings held in conformance with provisions of Title 17 of the Lodi Municipal Code and the laws of the State of California applicable thereto.

SECTION 3. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.




