AGENDA TITLE: Renewal of Landscape Maintenance Contract for 1995-96 Fiscal Year (\$43,000)

RECOMMENDED ACTION: That the City Council adopt the attached resolution approving renewal of the existing Landscape Maintenance Contract for the 1995-96 fiscal year to Ireland Landscape Company, Inc. of Stockton, California.

BACKGROUND INFORMATION: City Council originally approved the specifications for landscape maintenance on May 18, 1994. Section 1.5, General Stipulations, of the approved specifications allows for option to renew by mutual agreement between City and Contractor. Council awarded the contract to Ireland Landscape Company, Inc. on June 8, 1994. During the 1994-95 fiscal year, Ireland Landscape Company, Inc. has maintained forty-five landscaped areas for the City, providing satisfactory service. The City elects to exercise the option to renew. In the attached letter, Ireland Landscape Company, Inc. agrees to maintain the existing areas at the same rate for an additional twelve months, July 1, 1995 through June 30, 1996. Various departments included funds to finance the contract in the proposed 1995-96 operating budget.




