

RECOMMENDED ACTION: That the City Council adopt a resolution approving Program Supplement No. 009 to State-Local Agreement No. SLTPP-5154 for street improvements on Almond Drive, Stockton Street to Cherokee Lane.

BACKGROUND INFORMATION: This Program Supplement partially funds the Almond Drive, Stockton Street to Cherokee Lane, street improvement project under the State-Local Transportation Partnership Program as provided in Section 2600, et seq., of the Streets and Highways Code. Under this Program, the City will receive approximately 19.35% of the construction cost of this project up to a maximum of \$15,093. The matching funds for this project are Measure K funds approved in the 1994/95 Street Capital Improvement Budget.

This project is expected to go to bid shortly.

FUNDING: Measure K and SLTPP funds.


