RECOMMENDED ACTION: That the City Council authorize the purchase of the following SWAT Team safety equipment using Asset Seizure Funds:


Protech Entry II Safety Shield & Light	\$1,650
Five Glock Model 35 Pistols & Lights	\$3,630
Precision Marksman equipment to include: Rifle Scope, Spotting Scope, Radio/Headset And miscellaneous safety equipment to Outfit that Marksman/Member	\$7,500
TOTAL	\$12,780

BACKGROUND INFORMATION: In the event of emergency/tactical situations, the SWAT Team is called upon to respond and resolve high risk situations. The SWAT Team is also used for identified high risk search and arrest warrants. The above requested equipment provides for a higher level of safety for SWAT personnel and citizens and has been requested by the SWAT Commander to accomplish their mission. As the SWAT Team is the primary tactical entry team for high risk narcotic search warrants, asset seizure funds are a very appropriate funding source for this type of equipment.
