



RECOMMENDED ACTION: That the City Council adopt the attached resolution to purchase a station wagon for the Dial-A-Ride Program from Sanborn Chevrolet Geo, Inc. of Lodi, California, the low bidder, in the amount of \$21,048.09.

BACKGROUND INFORMATION: Funds to purchase a station wagon for the Dial-A-Ride Program were approved under the Transportation Development Act (TDA) Claim in the 1993/94 budget.
