AGENDA TITLE: Contract Award for Purchase of Radio Equipment for Narcotics/Gang Unit and Swat Team (\$46,320.90)

RECOMMENDED ACTION: That the City Council adopt the attached resolution awarding the purchase of 16 Motorola Saber-1 radios with batteries, microphones and chargers to the low bidder, Lagorio Communications of Manteca, in the amount of \$46,320.90, and to authorize the transfer of an additional \$2,035 from the Asset Seizure Account to complete this purchase.

BACKGROUND INFORMATION: On May 18, 1994, the City Council authorized the expenditure of \$44,286 of Asset Seizure Funds to purchase 16 secure-channel Motorola radios and related equipment for use by the Narcotics/Gang Unit and the Swat Team.

Bid packages were sent to four companies. Two bids were received, and opened on June 22, 1994:

Lagorio Communications, Manteca	\$46,320.90
Motorola Communications, Stockton	\$46,435.36

Because the low bid exceeded the estimated cost and the previously authorized expenditure amount, it is requested that the additional \$2,035 be transferred from the Asset Seizure Account to fund the entire purchase.
