AGENDA TITLE: Purchase of Type THHN Electrical Conductor for the Electric Utility Department (\$10,755.82)

RECOMMENDED ACTION: That the City Council adopt the attached resolution authorizing the purchase of a total of 58,500 feet of type THHN electrical conductor in various sizes from the low bidder, Capital Wholesale Electric of Sacramento, in the amount of \$10,755.82.

BACKGROUND INFORMATION: On October 5, 1994, the City Council approved specifications and authorized advertisement for bids. Bids were opened on October 19, 1994, with the following results:

Capital Wholesale Electric, Sacramento	\$10,755.82
Wesco Distribution, San Francisco	11,127.31
Excel Electrical Distribution, Sacramento	11,195.51
General Electric Supply, Sacramento	11,871.72

This wire will be used for the re-wiring of the streetlights in the downtown area. THHN conductor is a thermoplastic insulated stranded copper wire with nylon sheathing, rated at 600 volts, with a high resistance to heat and moisture.


