


Notice is hereby given that the claim which you presented to the City on October 17, 1994 is rejected as of the date of this letter.

Additionally, the Tort Claims Act contains certain exceptions. You may seek the advice of an attorney of your choice in connection with this matter. If you desire to consult with an attorney, you should do so immediately.

Please also be advised that, pursuant to Sections 128.5 and 1038 of the California Code of Civil Procedure, the City will seek to recover all costs of defense in the event an action is filed in this matter and it is determined that the action was not brought in good faith and with reasonable cause.
