RECOMMENDED ACTION: That the City Council adopt a resolution awarding the contract for the above project to The Thompson Group, of Emeryville, CA, in the amount of \$26,756.00 and appropriate funds in accordance with the recommendation shown below.

BACKGROUND INFORMATION: The City Council approved the above project during the 1998/99 Community Development Block Grant funding requests. This retrofit project will address the old tennis court area. The east tennis court will be resurfaced and re-striped for a full-size basketball court. The west court will be resurfaced for a half basketball court and handball court.

Plans and specifications for this project were approved on August 15, 2001. The City received one bid.
