The San Joaquin Regional Transit District sponsored a public meeting at Hutchins Street Square on October 19, 2001, at 2 p.m. to discuss unmet transit needs in Lodi and no comments were received. It should be noted that many of the comments are given directly via email to San Joaquin Council of Governments (SJCOG) staff throughout the year. Most comments received by SJCOG have pertained to commuter service to Sacramento and the Bay area.


