

RECOMMENDED ACTION: That the City Council adopt a resolution approving Program Supplement No. 36 to the Local Agency-State Agreement and authorize the City Manager and City Clerk to execute the agreement on behalf of the City.

BACKGROUND INFORMATION: This agreement covers the use of Federal Congestion Mitigation Air Quality Improvement Program (CMAQ) funds for the installation of the traffic signal at Turner Road and Lower Sacramento Road/Woodhaven Lane. The Federal funds will cover 100% up to \$100,000 of the construction and construction engineering. Based on recent bids, this amount should be sufficient to pay for the project. These funds are in addition to Federal Surface Transportation Program (STP) funds and are project specific. They cannot be used on any other project.

The plans and specifications for this project are now being reviewed by Caltrans and will be brought to the Council on April 21 for authorization to advertise.

FUNDING: 100% CMAQ funds.
