RECOMMENDED ACTION: That the City Council adopt the attached resolution awarding the contract for Lane Line Painting, Various Streets, 1993 to Traffic Limited, of P.O. Box 172*, Lodi, California 95241 in the amount of \$20,747.83.

BACKGROUND INFORMATION: This project provides painting of lane lines on arterial and collector streets on an annual basis and approximately 50 percent of lane lines on residential streets. Bids were opened on September 29, 1993 and two bids were received. The cost of painting a mile of lane line has decreased approximately four percent since the last time the City requested bids, which was October 1992.


