RECOMMENDED ACTION: That City Council set a public hearing for May 1, 1991, to discuss an amendment to the Refuse Franchise Agreement to provide for the addition of industrial customers.

BACKGROUND INFORMATION: On Wednesday, February 20, 1991, City Council considered the introduction of an ordinance to amend Chapter 13.16 - Solid Waste - of the City Code. This ordinance was tabled pending further review and recommendation on the matter by the City of Lodi Solid Waste Management Task Force.

The Task Force, at its regular meeting of Monday, March 25, 1991, voted to recommend that City Council approve the proposed amendment.

This subject is now ready to be brought back to the City Council for its consideration and action.




