AGENDA TITLE: Consider redraft of ordinance pertaining to the restriction of bicycling and organized track meets/events in the Nature Area at Lodi Lake Park

RECOMMENDED ACTION: Council consideration of introduction of attached draft ordinance.

BACKGROUND INFORMATION: As directed by the City Council at its April 3, 1991 meeting, attached is a draft of an ordinance addressing bicycles and athletic events in the Nature Area of Lodi Lake Park.

The new statute would prohibit the riding of bicycles in the Nature Area except upon the main trails, as designated by posted signs. In addition, it would prohibit all organized athletic events except cross country races, and would limit those cross country events to the ones sponsored in the past by such organizations as Lodi High School, Tokav High School, Field and Fair Day, etc. I believe this reflects the Council's desire that those events previously held in the Nature Area be "grandfathered" and that new events be prohibited.

FUNDING: None required.

ORDINANCE NO. 1510

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING LODI MUNICIPAL CODE CHAPTER 12.12 - PARKS -
BY ADDING THERETO A NEW SECTION 12.12.255
ENTITLED "LODI LAKE NATURE AREA: PROHIBITED ACTIVITIES"

BE IT ORDAINED BY THE LODI CITY COUNCIL AS FOLLOWS:

SECTION 1. Lodi Municipal Code Chapter 12.12 - Parks - is hereby amended by adding thereto a new Section 12.12.255 entitled "Lodi Lake Nature Area: Prohibited Activities", to read as follows:

Chapter 12.12

Parks

12.12.255 Lodi Lake Nature Area: Prohibited Activities

No person shall, within the Nature Area of Lodi Lake Park:

A. Ride, walk or operate any bicycle, tricycle, or similar human-powered conveyance, except upon the main trails, as designated by appropriate signs indicating bicycles are permitted. This section shall not apply to any law enforcement or Parks Department employee while carrying out his or her official duties;

B. Conduct or participate in any organized track and field or athletic event, without first obtaining written consent of the Parks and Recreation Director. As a matter of City policy to prevent overuse of and damage to the Nature Area, such consent shall be given only for cross country events and only to those organizations that had conducted cross country events in the Nature Area during the twelve-month period immediately prior to April 1, 1991.

C. Violation of this section shall be an infraction.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published the time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.






