RECOMMENDED ACTION: That the City Council adopt the attached resolution approving the purchase of a boom truck for the Public Works Department from Western Traction Company, Union City, California, for the amount of \$81,579.00.

BACKGROUND INFORMATION: Funds to purchase the boom truck for the Public Works Department were approved in the 1990-91 budget and specifications were approved by the City Council on March 20, 1991. Bids were opened on April 3, 1991 and three bids were received. The low bidder failed to meet the specifications.

WHEREAS, the City Manager recommends that award of the bid for one boom truck for the Public Works Department be made to the lowest qualifying bidder, Western Traction Co.;


