

RE: **Non-Qualifying Application for Board/Commission/Committee/Task Force
East Side Improvement Committee**

The Lodi City Clerk's office recently received your application of interest in being considered for re-appointment to the East Side Improvement Committee.

Your submission has been determined as a non-qualifying application because it does not meet the criteria outlined by the Lodi City Council for San Joaquin County (or City of Lodi) voter registration requirements as follows:

- a) **Per Resolution 2003-156, in order to be considered for appointment, a person must be a registered voter of *San Joaquin County* at the time of application.**
Exception ~ SPARC: A person must be a registered voter of the *City of Lodi* at the time of application.
- b) Per Ordinance 1736, in order to be considered for appointment to the Planning Commission, a person must be a registered voter of the *City of Lodi* at the time of application.

In ending your service with the Commission, it will be necessary for you to complete a Form 700 - Conflict of Interest Leaving Office Statement no later than 30 days from the date of this letter of notice (**due Monday, May 24, 2004 by 5:00 p.m.**) The original statement will be retained in the City Clerk's office or may be filed with Fair Political Practices Commission (FPPC).
