**AGENDA TITLE:** Set Public Hearing for March 2, 2005, to Consider Resolution Approving New Rates for Solid Waste Collection

**RECOMMENDED ACTION:** That City Council set a public hearing for March 2, 2005, to consider a resolution approving new rates for solid waste collection.

**BACKGROUND INFORMATION:** As a part of the franchise agreement with Central Valley Waste Services, rates for solid waste collection are to be adjusted annually. Section 7c of the franchise agreement states that starting April 1, 2005, rates shall be adjusted in a percentage amount equal to 80% of the annual change in the Consumer Price Index for all Urban Consumers for San Francisco-Oakland-San Jose, California area, All Items (1982-84=100). Exhibits A, B, and C show the current and new rates for solid waste removal services provided by Central Valley Waste Services.

**FUNDING:** None required. If approved at the public hearing, the new rates will be implemented by the City starting April 2005.


