ORDINANCE NO. 1524

AN ORDINANCE OF THE LODI CITY COUNCIL  
AMENDING THE OFFICIAL DISTRICT MAP OF THE CITY OF LODI  
AND THEREBY PREZONING THE APPROXIMATELY ONE ACRE PARCEL LOCATED AT  
1081 EAST STATE ROUTE 12 (COUNTY ADDRESS) AKA APN 027-040-14 FROM  
GA-40, GENERAL AGRICULTURE TO C-S, COMMERCIAL SHOPPING CENTER

BE IT ORDAINED BY THE LODI CITY COUNCIL AS FOLLOWS:

SECTION 1. The Official District Map of the City of Lodi adopted by Title 17 of the Lodi Municipal Code is hereby amended as follows:


The approximately one acre parcel located at 1081 East State Route 12 (County Address) AKA APN 027-040-14 from GA-40, General Agriculture to C-S, Commercial Shopping Center.

The alterations, changes, and amendments of said Official District Map of the City of Lodi herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearings held in conformance with the provisions of Title 17 of the Lodi Municipal Code and the laws of the State of California applicable thereto.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.




