RECOMMENDED ACTION: Information and/or action as deemed appropriate by the City Council.

BACKGROUND INFORMATION: At the City Council meeting of October 2, 1991, Council directed staff to meet with area residents to determine where best to relocate the scoreboard at Kofu Park.

Staff (Scott Essin, Parks Superintendent; Tim McGeorge, Parks Supervisor; Ron Williamson, Parks and Recreation Director; Steve Virrey, Parks Projects Coordinator) met with Don Miller, Professional Sports Marketing and the following residents that live on Cardinal Street (Mr. Nietschke, Mr. Rall, and Mr. Wong. Mrs. Flemmer communicated by telephone to Mr. Williamson). The new location for the scoreboard is detailed on the attached drawing. The bottom of the board will be approximately one foot above the base of the slope and the board will be in the tree canopy.

I have attached a layout of Kofu Park, notes of our agreement, and signatures by all who attended the meeting. (See Exhibit A). I remind the Council that to relocate the scoreboard will cost the City approximately \$5,000.00. (See Exhibit B).






