SUBJECT: ADOPTION OF ORDINANCE NO. 1478 - AM ORDINANCE OF THE LODI CITY COUNCIL AMENDING
LODI MUNICIPAL CODE SECTION 2.08.020 RELATING TO CITY COUNCIL SALARIES AS
AUTHORIZED BY GOVERNMENT CODE SECTION 36516 (a) (3)

Ordinance No. 1478 - "An Ordinance of the Lodi City Council Amending Lodi Municipal Code Section 2.08.020 Relating to City Council Salaries as Authorized by Government Code Section 36516 (a) (3)" was introduced at the regular meeting of the Lodi City Council held April 4, 1990.

Pursuant to State statute, ordinances may be adopted five days after their introduction following reading by title.

This Ordinance has been approved as to form by the City Attorney.

RECOMMENDED ACTION: Following reading by title, it would be appropriate for the Lodi City Council to adopt Ordinance No. 1478.

ORDINANCE NO. 1478

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING LODI MUNICIPAL CODE SECTION 2.08.020 RELATING TO CITY
COUNCIL SALARIES AS AUTHORIZED BY GOVERNMENT CODE SECTION 36516(a)(3)

BE IT ORDAINED BY THE LODI CITY COUNCIL.

SECTION 1. Section 2.08.020 of the Lodi Municipal Code relating to City Council salaries is hereby amended as authorized by Government Code Section 36516(a)(3) to read as follows:

"Each member of the council of the City shall receive, as salary, the sum of five hundred dollars (\$500) per month, as prescribed in Government Code Section 36516(a)(3) in cities over fifty thousand up to and including seventy five thousand in population, which shall be effective December 6, 1990 and shall be payable from and after the operative date of the ordinance codified in this chapter at the same time and in the same manner as the salaries are paid to other officers and employees of the city."

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.
