
SUBJECT: ADOPTION OF ORDINANCE NO. 1480 - AN ORDINANCE PREZONING THE SOUTH 2.66 ACRES OF THE PARCEL AT J693 EAST TURNER ROAD (ASSESSOR PARCEL NOS. 015-230-20 AND 29) FROM G-A, AGRICULTURE, SAN JOAQUIN COUNTY, TO C-1, NEIGHBORHOOD COMMERCIAL

Ordinance No. 1480 - "An Ordinance Prezoning the South 2.66 Acres of the Parcel at J693 East Turner Road (Assessor Parcel Nos. 015-230-20 and 29) from G-A, Agriculture, San Joaquin County, to C-1, Neighborhood Commercial" was introduced at the regular meeting of the Lodi City Council held April 4, 1990.

Pursuant to State statute, ordinances may be adopted five days after their introduction following reading by title.

This Ordinance has been approved as to form by the City Attorney.

ORDINANCE NO. 1480

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING THE OFFICIAL DISTRICT MAP OF THE CITY OF LODI
AND THEREBY REZONING THE SOUTH 2.66 ACRES OF THE PARCEL LOCATED AT
J693 EAST TURNER ROAD (ASSESSOR PARCEL 015-230-20 AND 29) FROM G-A,
AGRICULTURE, SAN JOAQUIN COUNTY, TO C-1, NEIGHBORHOOD COMMERCIAL

BE IT ORDAINED BY THE LODI CITY COUNCIL AS FOLLOWS:

SECTION 1. The Official District Map of the City of Lodi adopted by
Title 17 of the Lodi Municipal Code is hereby amended as follows:

The 2.66 acre parcel located at 5693 East Turner Road (Assessor Parcel
015-230-20 and 29) is hereby rezoned from G-A, Agriculture, San Joaquin
County, to C-1, Neighborhood Commercial.

The alterations, changes, and amendments of said Official District Map
of the City of Lodi herein set forth have been approved by the City
Planning Commission and by the City Council of this City after public
hearings held in conformance with provisions of Title 17 of the Lodi
Municipal Code and the laws of the State of California applicable
thereto.

SECTION 2. All ordinances and parts of ordinances in conflict
herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi
News Sentinel", a daily newspaper of general circulation printed and
published in the City of Lodi and shall be in force and take effect
thirty days from and after its passage and approval.
