
AGENDA TITLE: Purchase of Emulsion Distributor

RECOMMENDED ACTION: That the city council purchase the Emulsion Distributor from Nixon-Egli Equipment Company, Hayward, California, for the amount of \$25,732.69 and appropriate an additional \$1,987.69 from the Equipment Fund to finance the purchase.

BACKGROUND INFORMATION: Funds to purchase a Emulsion Distributor were approved in the 1989-90 operating budget and specifications were approved by the City Council on March 21, 1990. Bids were opened April 11, 1990 and one bid was received.

The bidder took an exception to the delivery date of 90 days after receipt of the purchase order and the \$50 penalty charge for each day after 90 days. The City and bidder have compromised and the delivery date has changed to 120 days after receipt of the Purchase Order and the penalty charge is \$25 for each day after 120 days.


The Finance Department has verified that the additional amount of \$1,987.69 is available in the Equipment Fund.

BE IT FURTHER RESOLVED, that the Council hereby approves the appropriation of an additional \$1,987.69 from the Equipment Fund to finance the purchase.
