
SUBJECT: ADOPTION OF ORDINANCE NO. 1486 - AN ORDINANCE OF THE LODI CITY COUNCIL AMENDING  
LODI MUNICIPAL CODE SECTION 13.16.010(I) BY DELETING FROM THE DEFINITION OF  
"REFUSE" ALL INFECTIOUS WASTE

Ordinance No. 1486 - "An Ordinance of the Lodi City Council Amending Lodi Municipal Code Section 13.16.010(I) by Deleting from the Definition of 'Refuse' all Infectious Waste" was introduced at the regular meeting of the Lodi City Council held May 2, 1990.

Pursuant to State statute, ordinances may be adopted five days after their introduction following reading by title.

ORDINANCE NO. 1486

AN ORDINANCE OF THE LODI CITY COUNCIL  
AMENDING LODI MUNICIPAL CODE SECTION 13.16.010(I)  
BY DELETING FROM THE DEFINITION OF "REFUSE" ALL INFECTIOUS WASTE

BE IT ORDAINED BY THE LODI CITY COUNCIL AS FOLLOWS:

SECTION 1. Lodi Municipal Code 13.16.010(I) is hereby amended by deleting from the definition of "Refuse" all infectious waste as follows:

CHAPTER 13.16

SOLID WASTE

Section 13.16.010 DEFINITIONS.

For the purposes of this chapter, unless otherwise apparent from the context, the following definitions apply:

I. "Refuse" means any and all discarded items and substances of every kind, including salvageable or recyclable materials, and garden wastes, but not including infectious wastes, sewage, septic tank contents, or hazardous wastes as defined by state and/or federal law."

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi Mews Sentinel", a daily newspaper of general circulation printed and

ished in the City of Lodi and shall be in force and take effect  
ty days from and after its passage and approval.
