RECOMMENDED ACTION: That the City Council adopt the attached resolution awarding the contract for lane line painting, various streets, 1992 to Traffic Limited, Lodi, California, in the amount of \$18,788.34.

BACKGROUND INFORMATION: This project provides painting of lane lines on arterial and collector streets on an annual basis and approximately 50 percent of lane lines on residential streets. Bids were opened on September 30, 1992 and four bids were received. The cost of painting a mile of lane line has decreased approximately six percent since the last time the City requested bids, which was September 1991.
