PREPARED BY: Assistant City Manager

- RECOMMENDED ACTION: That City Council take the following actions:
- a) Table Ordinance No. 1562
 - b) Table Ordinance No. 1512
 - c) Table Ordinance No. 1513
 - d) Set public hearing for December 16, 1992, to consider adopting an urgency ordinance amending commercial rates relating to 10 to 50 cubic yard roll-off boxes.
 - e) Set public hearing for December 16, 1992, to consider introduction of an ordinance regarding all industrial waste haulers.

BACKGROUND INFORMATION: At its meeting of November 4, 1992, City Council considered the adoption of Ordinance No. 1562 (establishing industrial rates), Ordinance No. 1512 (establishing industrial refuse collection as a service which must be provided by the City's contract waste hauler) and Ordinance No. 1513 (amending the City's franchise for waste disposal services to include industrial waste).

Council examined *many* issues relative to these ordinances. Of primary concern was that while *many* industrial customers would see rates fall, *many* others would see their rates escalate. Kevin Van Steenberge of Lodi Iron Works, Inc. expressed concern with substantially higher waste collection rates facing his firm. The rate structure schedule proposed on November 4, 1992 included a \$25.00/ton processing charge. In part, this reflects the new practice at the county landfill of charging tipping fees based on weight, rather than volume. Lodi industries which generate large tonnages of waste would therefore face higher rates.

After reviewing these issues, Council directed Dave Vaccarezza, President, California Waste Removal Systems (CWRS), to contact all industrial customers in Lodi and inform them of the impact of the proposed ordinances and request their attendance at the next Council meeting.

After meeting with industrial representatives, CWRS has requested a significant change. CWRS no longer desires a franchise for the collection of industrial waste. Given this, Ordinances 1512, 1513, 1562 may be tabled by Council with no further consideration.

Discussions with Mr. Vaccarezza and input from the last public hearing has led staff to believe it would be in the best interest of all parties if the market were allowed to set the rate for collection and disposal of industrial waste and provide industrial Customers with the right to choose the carrier that serves them best.

The City has a large stake in this decision in that the City must have control of the flow of all solid waste so we can meet AB 939 mandates. In fairness to all haulers there should be some uniformity in their relations with the City. So all haulers are treated fairly, the City knows who the haulers are, and receives funds for allowing people to do business in the City, and has control over the flow of waste so AB 939 mandates are met, the following recommendations are made and will be included in an ordinance to be introduced on December 16, 1992:

- a) All collectors of industrial solid waste must have a business license.
- b) All collectors of industrial solid waste must pay a franchise fee equal to 4% of the cost of collection and disposal.
- c) All solid waste collected in the City of Lodi must go through a State licensed Material Recovery Facility.

So that there is standardization of charges for collection and disposal of commercial solid waste collected in roll-off boxes or collection that is out of the normal course of events, Council is asked to conduct a public hearing to consider adopting standardized rates for this service. Roughly 15 commercial customers in Lodi will be affected by these rates. This will be presented as a separate item.

ORDINANCE NO. 1562

AN UNCODIFIED URGENCY ORDINANCE OF THE LODI CITY COUNCIL
AMENDING LODI MUNICIPAL CODE CHAPTER 13.16,
RELATING TO INDUSTRIAL SOLID WASTE COLLECTION RATES

=====

BE IT ORDAINED BY THE LODI CITY COUNCIL, as follows:

SECTION 1. Lodi Municipal Code Chapter 13.16 " SOLID WASTE - as it relates to industrial solid waste collection rates is hereby amended to read as follows:

Rates.

A. The rates to be charged for garbage collection service shall be as follows:

1. For owners or tenants of business houses, the rates shall be as set forth in the Industrial Rate Structure schedule attached, when industrial bin service is requested.

B. All of the rate schedules set forth in this section shall be effective on all bills which are prepared on or after December 1, 1992.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This is an urgency ordinance under Government Code Section 36934, and is based on health, safety and welfare

considerations arising from the need to collect appropriate fees for waste removal.

SECTION 4. This urgency ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect immediately.

ORDINANCE NO. 1512

AN ORDINANCE OF THE LODI CITY COUNCIL AMENDING LODI MUNICIPAL
CODE CHAPTER 13.16 - SOLID WASTE - TO PROVIDE FOR THE ADDITION OF
INDUSTRIAL REFUSE SERVICE.

=====

BE IT ORDAINED BY THE LODI CITY COUNCIL, as follows:

Lodi Municipal Code Chapter 13.16 " Solid Waste " is hereby amended to provide for the addition thereto of industrial refuse service, as follows:

13.16.020. Required Services: Exceptions.

A. "Every person owning or occupying residential, commercial or industrial premises within the City limits shall utilize the refuse collection and transportation services of Contractor for which the City has contracted, and shall pay the fees for those services as set by the City. Each owner Or occupier of residential, commercial or industrial property shall directly arrange with the City for the provision of servicee. ..."

13.16.040. All Requests for Service to be Met.

"Contractor shall provide refuse collection and transportation services to all residential, commercial and industrial customers within the area specified in its contract. ..."

13.16.050. Placement of Containers.

A. "... B. Commercial and Industrial:

"Commercial and industrial customers shall place refuse in a location on their premises that is readily accessible to Contractor's collection vehicles, and that has received Contractor's prior approval as conforming to its specifications and requirements for refuse container facilities. ..."

13.16.080. container Maintenance.

"... It shall be the responsibility of commercial and industrial customers to maintain refuse containers in a clean and sanitary condition, ... "

13.16.120 Monthly Rates.

"The City shall establish by uncodified ordinance of the City Council, pursuant to Health and Safety Code Section 5471, a schedule of rates to be charged ... Such schedule shall set the rates for commercial, residential, and industrial refuse collection, and refuse permits."

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.

ORDINANCE NO. 1513

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING THE CITY'S EXCLUSIVE FRANCHISE
FOR WASTE DISPOSAL SERVICES TO INCLUDE INDUSTRIAL WASTE

=====

WHEREAS, on September 28, 1988 under Ordinance 1433, the Lodi City Council granted to Lodi Sanitary City Disposal Company, Inc. the exclusive right to collect all residential and commercial waste within the City Limits; and

WHEREAS, it now appears necessary and desirable to modify that Agreement to include the collection of industrial waste; and

WHEREAS, the Lodi City Council hereby determines pursuant to Public Resources Code Section 40059 that the public health, safety and well being require that refuse collection services in the City of Lodi, including collection of industrial waste, be provided by means of an exclusive contract without competitive bidding; and

WHEREAS, Lodi Sanitary City Disposal Company, Inc., a California corporation, is qualified to perform such refuse collection services by means of such contract in the interests of public health, safety, and well being;

NOW, THEREFORE, THE M D I CITY COUNCIL ORDAINS as follows:

SECTION 1. The Agreement entered into between the City and Lodi Sanitary City Disposal Company, Inc. on September 7, 1988 is hereby amended as described in the Addendum to the Agreement attached hereto.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.

M O D I F I C A T I O N T O A G R E E M E N T

THIS MODIFICATION TO THE AGREEMENT DATED SEPTEMBER 7, 1988 (the Agreement) is entered into this 4th day of November, 1992, by and between the parties to the original Agreement. All terms of the original Agreement, save and except those additions, deletions, and modifications specified herein, shall continue.

R E C I T A L S

Paragraph 1 (Definitions) is modified by the addition thereto of a subsection (d) as follows:

d. Industrial Customers

All industrial customers within the City limits.

Paragraph 2 shall read:

2. "Scope of Agreement

"Contractor shall furnish all materials and equipment required for the orderly collection of refuse on a regularly-scheduled basis to all residential, industrial, and commercial customers
... "

Paragraph 3 shall be modified to read:

3. "Exclusive Nature of Agreement

Contractor shall have within the City limits, subject to the limitations contained in this Agreement, the exclusive right and duty to collect and transport to a site designated by the City all residential, commercial, and industrial refuse."

Paragraph 6 shall be modified by the addition thereto of a subparagraph c. as follows:

c. Industrial Customers

(Collection schedule to be added.)

Paragraph 8 shall be modified, to include industrial collection, as follows:

"8. Hours of Collection

" ... Industrial collection shall be made on an "as needed" basis, subject to agreement between the contractor and industrial customer."

Paragraph 30 shall be modified to delete reference to Lodi Municipal Code Section 13.16.060 which section no longer relates to insurance liability, as follows:

"30. Liability Insurance

"... In this connection, Contractor agrees to furnish the City with evidence of Workers' Compensation Insurance coverage and a certificate of insurance showing a minimum of \$500,000 for damage to property, and \$1,000,000 for injury to persons, with the City of Lodi named as an additional insured on said policy."


In review of our contract it states that the rates established shall be reviewed annually during the month of June, and if appropriate, adjusted effective July 1.

We would like to request an amendment to our present franchise agreement to extend the time frame on the entire rate review process. We make this request for the following reasons:

1. Technically, it is extremely difficult for our outside accountants to produce audited financial statements by June 1st of each year. Our fiscal year ends March 31st each year, and it takes a considerable amount of time to closeout the year and make a 60 day turnaround for finalized, audited financial statements by June 1st of each year. This year's statements will not be readily available until the end of the June. As a result, each year we come to the City asking for an extension of time.

2. In light of the new requirements of AB939, the City of Lodi may make a dramatic operational change in refuse collection, and this will effect the rate;


3. Finally, due to recent developments with regard to the industrial customer8 coming under the franchise, this too will effect the rate.



The above three variables provide for a complex determination of rates which in turn necessitates a longer time period than one month to review as required in the present contract. Therefore, we would like to propose that the contract be amended to review the rates through the month of September, and new rates be put into effect October 1st of each year.

Please consider our request, and I will contact you to discuss it further.
