ORDINANCE NO. 1423

AN ORDINANCE OF THE CITY OF LODI RELATING TO
STANDARDS AND TRAINING FOR CORRECTIONS PROGRAM

The City Council of the City of Lodi, State of California, does ordain as follows:


Section 1. While receiving any State Aid pursuant to Article 3, commencing with Section 6040 of the California Penal Code, the City of Lodi will adhere to the standards for selection and training established by the Board of Corrections.

Section 2. This ordinance shall take effect 30 days after its adoption.

Section 3. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.


Section 4. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi, and shall be in force and take effect thirty days from and after its passage and approval.
