The Lodi City Council at its October 4, 1989 meeting awarded to you the Tree Trimming Contract in the amount of \$55.885 per hr. (evaluated 90% - 10%), as defined in the specifications. Three copies of the contract are enclosed. Please sign the original and one copy and return to our office. When the Mayor has executed the contract, one copy will be forwarded to you.

As indicated in Section 2.1000 of the specifications, you are required to furnish a faithful performance bond in the amount of \$20,000. A copy of this bond is enclosed. You are required to name the City as an additional insured on your property damage, public liability, and automobile insurance. Please give the Instructions/Requirements for Insurance Coverage to your insurance agent. You are also required to furnish a copy of your Worker's Compensation Insurance coverage as specified in Section 2.1300 of the specifications. One fully executed copy of the bond and necessary insurance documents should be returned with the contract and prior to the start of the work under this contract.

If you wish to leave your equipment in the City's Corporation Yard, as was done during the previous contract, please submit a statement with the appropriate company signature indicating that Asplundh assumes all physical damage liability for its vehicles and equipment while parked on City property.

We have also enclosed for your information a bid summary showing the bids received.
