ORDINANCE NO. 1397

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING THE LODI MUNICIPAL CODE BY ADDING A
NEW SECTION UNDER CHAPTER 5.04 - BUSINESS LICENSES GENERALLY

BE IT ORDAINED BY THE LODI CITY COUNCIL

SECTION 1. Lodi Municipal Code Chapter 5.04 - Business Licenses
Generally is hereby amended to add a new section as follows:


"Section _____. Violation-Infraction.

"Any violation of this Chapter is an infraction unless the
defendant has been convicted of three or more violations of a
particular section within the twelve-month period immediately
preceding the commission of the offense, and then the violation
of this Chapter constitutes a misdemeanor."

SECTION 2. All ordinances and parts of ordinances in conflict
herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi
News Sentinel", a daily newspaper of general circulation printed and
published in the City of Lodi, and shall be in force and take effect
thirty days from and after its passage and approval.
