APPROVE THE NAMING OF "E" BASIN, LOCATED AT THE SOUTH BOUNDARIES OF LODI PARK WEST SUBDIVISION BETWEEN APPLEWOOD DRIVE AND EVERGREEN DRIVE

PREPARED BY: City Manager

RECOMMENDED ACTION: That the City Council review the submittals for the naming of "E" Basin/Park, consider the recommendation of the Parks and Recreation Commission, and take action as deemed appropriate.

BACKGROUND INFORMATION: The Parks and Recreation Commission recently initiated a "name-the-park" campaign for the purpose of recommending to the City Council a name for the "E" basin/park (Park West Subdivision). The contest was advertised in the Lodi News-Sentinel, and fliers were placed in various public locations. Attached (Exhibit A) is a list of the names submitted. At its regular meeting of February 3, 1987, the Parks and Recreation Commission took action to recommend to the City Council that this basin/park be named "Westgate Park". The Parks and Recreation Director advises that while the vote was unanimous, the Commission is cognizant that this is a recommendation only, and that any action by the City Council to the contrary would be understood.






CITY OF LODI
