ORDINANCE NO. 1283

AN ORDINANCE AMENDING THE LAND USE ELEMENT OF THE GENERAL PLAN OF THE CITY OF LODI BY REDESIGNATING THE PARCEL AT 1332 SOUTH HUTCHINS STREET, LODI, FROM MEDIUM DENSITY RESIDENTIAL TO GENERAL COMMERCIAL

The City Council of the City of Lodi does ordain as follows:

Section 1. The Land Use Element of the General Plan of the City of Lodi is hereby amended by redesignating the parcel at 1332 South Hutchins Street, Lodi, California, from Medium Density Residential to General Commercial.

Section 2. All ordinance and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and

shall be in force and take effect thirty days from and after its passage and approval.
