
Dear Mr. Weekes:

RESOLUTION APPROVING AGREEMENT BETWEEN THE CITY OF  
LODI AND THE COUNTY OF SAN JOAQUIN FOR CERTAIN  
SERVICES TO BE PROVIDED BY THE COUNTY OF SAN  
JOAQUIN FOR THE APRIL 10, 1984 CITY OF LODI  
MUNICIPAL ELECTION

A G R E E M E N T

THIS AGREEMENT, made this 7th day of March, 1984, between the COUNTY OF SAN JOAQUIN, a political subdivision of the State of California, hereinafter called "COUNTY" and the CITY OF LODI, a municipal corporation hereinafter called "CITY".

W I T N E S S E I H

WHEREAS, the City of Lodi desires to hold a Municipal Election to be held on the 10th day of April, 1984, and the City desires to make use of certain services and equipment of the Registration-Election Department of the County and to pay the County for its cost thereof, pursuant to the provisions of this Agreement.

NOW, THEREFORE, it is hereby agreed as follows:

1. The County agrees to make no changes in precinct boundaries within ninety (90) days of the City of Lodi Municipal Election on April 10, 1984.
2. The County agrees that the Registration-Elections Department shall do the following things for the City:
  - (a) Furnish the governing body of the City, upon request of the City Clerk, with as many copies as may be needed of the index of registration for each precinct contained in the City of Lodi, up to and including twenty-nine (29) days prior to the election.
  - (b) Furnish address labels, indexes and roster indexes of the eligible voters in the City of Lodi.
  - (c) Use of the election supplies as need by the City.
3. The City agrees to pay the County for its costs for all services and supplies furnished to the City in connection with said Municipal Election, immediately upon receipt by the City of a statement from the County setting forth the actual cost

to the County for services and equipment so furnished.
