ORDINANCE NO. 1375

AN ORDINANCE AMENDING THE LAND USE ELEMENT
OF THE GENERAL PLAN OF THE CITY OF LODI
(GPA-LU-86-1) CONSISTING OF TWO SECTIONS

THE CITY COUNCIL OF THE CITY OF LODI DOES ORDAIN AS FOLLOWS:

Section 1 - The Land Use Element of the General Plan of the City of Lodi is hereby amended as follows:

- a) The redesignation of a portion of the lot at 238 South Pleasant Avenue, Lodi, from Office-Institutional to Commercial.
- b) The redesignation of a 4.0 acre parcel proposed for the northwest corner of Cherokee Lane and East Century Boulevard from Commercial to Medium Density Multiple Family.

Section 2 - All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3 - This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


