SUBJECT: GENERAL PLAN - LAND USE ELEMENT AMENDMENT GPA-LU-87-1

RECOMMENDED ACTION:

At its meeting of Monday, March 9, 1987, the Lodi City Planning Commission recommended that the Lodi City Council amend the Land Use Element of the Lodi General Plan (GPA-LU-87-1) by redesignating 1340 South Pleasant Avenue from Medium Density Residential to Commercial.

BACKGROUND:

The structure at 1340 South Pleasant Avenue is located at the northeast corner of South Pleasant and Kettleman Lane and is the site of a single-family dwelling. The property is located north of the Lucky-Thrifty shopping center and easterly of an automobile service station. The Planning Commission's recommendation for a commercial designation was based on existing traffic and development in the area.




