
We would like if at all possible to have the stadium tax of \$.35 per person waived for this event. This tax would cut very severely into the profit and dampen our chances of having a totally successful game.

MEMORANDUM

TO: Mr. Henry Glaves Jr., City Manager

DATE: March 30, 1984
SUBJECT: STADIUM RENTAL - ALUMNI FOOTBALL GAME

Occasionally we make an exception regarding Stadium rental fees. Normally 35¢ per head is charged or some \$350.00 per 1,000 attendance, plus \$50.00 for lights and usually \$150.00 for cleanup. Last year for the Band Review we made a special rate (see attached statement).

I would recommend we charge the football people a flat fee of \$250.00 for use of the field, plus \$50.00 for lights, \$50.00 for park maintenance, plus \$50.00 for cleanup, for a total of \$400.00. In turn the football users will receive a football field - lined, use of the down markers, lights, p.a. system, and cleanup.

I will donate my time with regards to being present to open and close, turn lights on and off etc.

Hopefully this will be of help to you and the council.
