ORDINANCE NO. 1380
ORDINANCE OF THE LODI CITY COUNCIL
AMENDING TITLE 10, CHAPTER 10.20.230
OF THE LODI MUNICIPAL CODE ENTITLED
CITY PARKING LOTS - REGULATION GENERALLY

BE IT ORDAINED BY THE LODI CITY COUNCIL

SECTION 1. Title 10, Chapter 10.20.230 of the Lodi Municipal Code is hereby Amended by the addition of Subsection "C" which shall read in full as follows:

10.20.230 - City Parking Lots - Regulation Generally

- C. When the City Manager has authorized the City Engineer to install and maintain parking space markings to indicate parking spaces within the City Parking Lot, no vehicles shall be stopped, left standing or parked other than within a single space unless the size or shape of such vehicle makes compliance impossible.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage approval.
