

RESOLUTION AUTHORIZING LEGISLATIVE

BE IT RESOLVED that the City Council of the City of Lodi does hereby direct that appropriations be made to various salary and fringe benefit accounts as per MEMORANDUMS OF UNDERSTANDING with General Services, Maintenance and Operators, Dispatchers, Department Heads, Police and Fire, as approved by the City Council, from the following reasonable and proper accounts:

SECTION 1

General Fund Operating Reserve	\$347,461
Sewer Utility Fund-Operating Reserve	\$ 23,579
Gas Tax Fund (2107)	\$ 14,011
Water Utility Fund-Operating Reserve	\$ 11,798
Special County Transportation Fund	\$ 2,016

SECTION 2

That the sum of \$1,220 be and it is hereby transferred from the General Fund Operating Reserve to the Community Center Fund.


