
RECOMMENDED ACTION: That the City Council award the contract for the above project to C.P. National in the amount of \$63,901.60.

BACKGROUND INFORMATION: This project is the completion of the Church/Park watermain project and the Poplar Street watermain project. Phase I of the Church Street project (north of Vine) was done last year prior to a street overlay. The Poplar Street project is being done for the Galatsatos project on 322 Poplar Street per Council action on May 22, 1985.

Plans and specifications for this project were approved on March 26, 1986.
