HOUSING ESTIMATES

CC-36

Annually, the California State Department of Finance prepares population and housing estimates for each city and county in the state. The estimates are based on information provided by the local agencies and include data on new residential construction, school enrollment, utility accounts and mobilehome occupancy.

Copies, of the January 1, 1985 and January 1, 1986 estimates, which indicates a growth in population of 1970 and in housing units of 984. Staff reported that both of the estimates appear to be in line with the City's present growth activities.

In order to use the 1986 population estimate of 43,293 for the City of Lodi as of 1/1/86, as estimated by the California State Department of Finance as the basis for state subventions, Council adopted Resolution No. 86-66 authorizing the City Manager and City Clerk to request certification of the population and housing estimates as required by Section 2077.2 of the Streets and Highway Code.
