RENEWAL OF COOPERATIVE PERSONNEL SERVICES CONTRACT

The City of Lodi utilizes the services of Cooperative Personnel Services almost exclusively for purposes of acquiring written examination for most recruitments for City positions. The existing contract for personnel examining services between the City of Lodi and Cooperative Personnel Services expires in June, 1984. For the City to continue to receive these services, a contract renewal effective this month, is needed. It is recommended the contract be extended for three years, the maximum time in which a renewal may be effected.

ACTION RECOMMENDED:

1. Approval of entering into a contract for the performance of technical personnel services; and
2. An action by the City Council authorizing City Manager to sign the contract in its behalf.

ACTION REQUIRED:

1. Adoption of resolution authorizing the entering into an agreement with the State Personnel Board, Cooperative Personnel Services Division, for the purpose of performing Examining Services for the City of Lodi.
