Assistant City Manager Glenn apprised the Council that historically Council has been asked to appropriate funds for Dial-A-Ride as part of the Capital Budget. This year the Capital Budget was not presented to the City Council until October 15, 1981. At that time Council was involved with viewing the feasibility of providing a fixed route transit system and looking at funding through State transit assistance funds. Therefore, the decision was made to withhold making a specific appropriation of funds for Dial-A-Ride until these questions were resolved.


