Council approved and authorized the City Manager and City Clerk to execute the renewal of the Landscape Maintenance Contract with Ireland Landscape Co., Inc., for the 1983-84 Fiscal Year. The total annual cost of the contract is \$25,368.00 which reflects an increase of \$1,572.00 which provides funds to maintain three new sites; namely, Well #19, Lawrence Park and the Hutchins Street Median.


**RECOMMENDED ACTION:** That the City Council approve and authorize the City Manager to execute the renewal of the Landscape Maintenance Contract to Ireland Landscape Co., Inc., Stockton, CA for the 1983-84 fiscal year.

**BACKGROUND INFORMATION:** Ireland Landscape Co., Inc. maintained landscape areas within the City of Lodi during the 1982-83 fiscal year. They have agreed in their letter dated February 23, 1983 to maintain existing areas in the 1982-83 fiscal year at the same rate per site for an additional twelve months, the period July 1, 1983 through June 30, 1984.

The City has landscaped two additional sites in the past two months which are Well #19 and Lawrence Park and a third site should be completed during the summer months, which is the Hutchins Street median. We have received quotes for those areas and included them in the renewal contract. Maintenance of Lawrence Park and Well #19 would start July 1, 1983, maintenance of the Hutchins Street median would commence when planting is completed.

We have experienced satisfactory services from Ireland Landscape Co., Inc. considering the extended period of inclement weather, and find it justified to recommend the renewal of the existing contract. The total annual cost of the contract is \$25,368 an increase of \$1,572 which provides funds to maintain the three new sites.

Funds to finance the contract are included in the 1983-84 Operating Budget.
