

City Manager Graves presented the following bids which had been received to supply 5,000 gallons of asphalt rejuvenating agent:



SUBJECT: Award Bid for Asphalt Rejuvenating Agent


RECOMMENDED ACTION: That the City Council award the bid to supply 5,000 gallons of asphalt rejuvenating agent to Reed & Graham, Inc., Auburn, California.

BACKGROUND INFORMATION: The specifications for the asphalt rejuvenating agent were approved by the City Council at its meeting on May 20, 1981 and two (2) bids were received.

Asphalt rejuvenating agent costs have increased 10% since the last time the City requested bids which was August 1980.


