

MEETING DATE: June 3, 1987
AGENDA TITLE: Approve Installation of "Stop" Sign on Century Boulevard at Cherokee Lane

RECOMMENDED ACTION: That the City Council adopt a resolution for the installation of a stop sign on Century Boulevard at Cherokee Lane and give the Public Works Director authority to install a stop sign on Cherokee Lane southbound at Century Boulevard in the future if needed.

BACKGROUND INFORMATION: Century Boulevard is being constructed at Cherokee Lane as part of the Johnson-Tandy Ranch project. Currently, Cherokee Lane northbound traffic stops for Cherokee Lane southbound traffic. Cherokee Lane southbound on-ramp volumes are high compared to the short-term projected traffic volumes on Century Boulevard. For this reason, staff does not recommend a multi-way stop control at this time. As shown in the attached exhibit, staff does recommend installing a special regulatory sign at both Cherokee Lane northbound and Century Boulevard approaches.

As the Johnson-Tandy Ranch project develops, the Century Boulevard traffic may be higher than projected volumes, causing considerable delay for motorists and a potential accident problem. Staff recommends the City Council give the Public Works Director authority to install a stop sign at Cherokee Lane southbound when needed.






RESOLUTION APPROVING INSTALLATION OF "STOP" SIGNS
